Ms. Nicole Williams is not only an experienced practitioner leading THT but also an autism mom and long-time volunteer of TACA. As such, she understands and values the dedication of TACA’s parent volunteers across the country who work to serve not only their families but the community of families around them.

**Offer:** Discount to The Health Terrain Fullscript Dispensary to ACTIVE TACA Volunteer and TACA staff for appointments held from November 2024 to July 31, 2025. A completed application and benefit letter will be provided to qualified TACA Volunteers to redeem the discount at THT’s Fullscript; the benefit letter must be provided before a discount and access to a THT Fullscript account. The discount cannot be applied retroactively.

**Details:** This offer will be available to qualified ACTIVE TACA Volunteer and TACA staff from November 1, 2024, to July 31, 2025. The discount applies to access to the THT Fullscript account and beneficiaries agree to share information with TACA and THT in order to access the discount. The discount will be rolled out first to TACA ACTIVE Leadership and Legacy members (who have a



completed Volunteer Agreement) and Staff members. The discount will be rolled out to active TACA Mentors as of January 1, 2025. The discount tiers are as follows for active volunteers:

- TACA Leadership, Legacy, and staff: 30% discount and free shipping for orders of \$50 or more;
- TACA Mentors: 25% discount and free shipping for orders of \$50 or more.
- Application or participation in this benefit is at-will and can be canceled at any time by either party or individual.

**Execution and Follow-Up:** TACA will provide qualified volunteers with a benefit letter to redeem with THT before any account is made. Benefit letters will be verified, and numbered, and an approved list with pertinent personal information will be provided to THT to receive the benefit. TACA will hold quarterly check-in meetings to ensure the success of the benefit.

- **Application:** Interested volunteers can apply for the THT volunteer benefit by completing the benefit application. Participants who already have a Fullscript account with another practitioner should utilize a different email to access this benefit.
  - TACA Mentor Coordinator will review and ensure volunteer qualifies to receive the benefit. Please allow 2 weeks for processing and review.
  - Applications will close **July 1, 2025**.
  - A benefit letter and list with personal information will be provided to the volunteer to access the benefit from THT
- **Volunteer Qualification:**
  - Volunteers should be active TACA Mentors. Qualified applicants would be Leaders, Legacy, Mentors, and/or staff who have completed all TACA training, completed data, have signed a Volunteer Agreement, and are able and willing to accept matches or are actively mentoring. New mentors should be active for a minimum of three months before applying. In addition, TACA Mentors should be:
    - Responsive to the TACA Mentor Coordinator;
    - An active TACA volunteer with a current Volunteer agreement;
    - As of the start date of the benefit, TACA mentors who may have been retired for longer than 6 months need to demonstrate three (3) months of activity to become eligible to apply.
  - Volunteer in Good Standing: has provided data for all of 2024, commits to completing data monthly for the duration of the program incentive, and has completed all training.
  - Failure to maintain the program's qualifications through the duration of the benefit year may result in revocation of this benefit and becoming ineligible for future offers and program benefits.
